

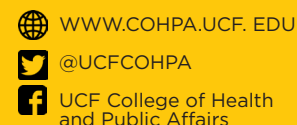

### »» Sponsored Research Funding – \$8.5 million in 2016-17

#### Grant Highlights

- Shawn Lawrence (Social Work) received a \$915,000 grant from the **Substance Abuse and Mental Health Services Administration** to train students and local health care providers to use the SBIRT protocol, shown to reduce and prevent substance abuse disorders.
- Jennifer Kent-Walsh (Communication Sciences and Disorders) secured a \$437,812 grant from the **National Institutes of Health** to evaluate the impact of an augmentative and alternative communication (AAC) intervention program for preschool children with severe speech disabilities.

### »» Partnership Highlights

- The Center for Community Schools partners with school districts and communities throughout Florida to plan, implement and evaluate the Community Partnership Schools™ model, first implemented at Evans High School in Orlando. The center received \$1 million from the state Legislature to support its efforts in 2017-18.
- The Doctor of Physical Therapy program partners with internationally known scientist and inventor Cole Galloway at the University of Delaware to establish programs that enhance mobility in children and adults with a disability. These include UCF Go Baby Go! and Knights on the Go Café.
